#### **SETUP:**

We will be setting up on Thursday night at 6:00 PM. Equipment will be at the soccer center so it will just be setting up the rings. NO general setup. Only exhibitors that help set the rings and course can set up their mats and crates Thursday night. Otherwise the building will be open Friday morning at 7:00 a.m.

Crate mats/tarps are required underneath crates or X-pens per facility policy.

X-pens will be allowed. If dogs are lunging you will be asked to crate dogs & dogs that bark excessively in their crates will be covered, or you may be asked to crate from your car.

Flexi Leads are not allowed at the trial site.

#### Check-in:

We will be using **AGILITY GATE** for this trial. There will be no paper copies provided. Courses will be posted on Agility Gate and also <u>www.agilitydirections.com</u>. The code for Agility Gate will be 0425. Running orders and course maps will be posted on this site daily.

Our Judge, Darryl Warren, is a VMO. If your dog is under 2 yrs and does not have a Temporary height card your dog will need to be measured before you run. If your dog is over 2 yrs old and has not been measured your dog will need to be measured before you run or needs second measurement for a Permanent Height card your dog should be measured.
